	boundaries, prevention of substance abuse, safe use of the internet and social
	media, awareness of resources, and how to safely seek assistance.
Grades 6-12	Using crosswalk lessons provided within our "Safer, Smarter Teens" curriculum
	as well as resources at <u>www.fldoe.org</u> , School Resource Deputies and designated
	instructors will provide age appropriate instruction to include recognizing the
	signs of human trafficking, developing awareness of resources, preventing
	substance abuse, reducing the risk of human trafficking, setting healthy
	boundaries, knowing how to safely report/seek assistance, and understanding
	how social media and mobile device applications are used for human trafficking.

#### **Data Tracking & Reporting**

- I. The Coordinator of Safety and Mental Health, School Safety Specialist, will provide a report to the Commissioner of Education by **July 1**<sup>st</sup> of each year verifying completion of instruction.

  - b. The professional qualifications of those delivering instruction.
  - c. A description of the materials and resources utilized to deliver instruction.
